NEW BANKRUPTCY STATUTE

On October 27, 1986, the President signed the United States Bankruptcy Judges, Trustees and Family Farmer Acts of 1986. This statute provides for a new Bankruptcy Judge in the Western District of Michigan; no change is made in the Eastern District of Michigan. There will be a United States Trustee for Michigan and Ohio; however, this part of the statute won't be effective for nine months to one year from now. The Family Farmer Act provides for a new Chapter 12 which increases debtor rights against secured creditors. Further information will be provided by the Bankruptcy Committee as received.
