PRESIDENT'S MESSAGE

It is with both excitement and trepidation that I undertake my year of service as President of the Detroit Chapter of the Federal Bar Association. It is exciting because we have a dynamic organization which is attempting to meet the needs of a broad cross-section of the government and private bar. It is personally daunting to think of myself in the company of that distinguished list of past presidents which adorns our letterhead. It is my intention to exercise the privilege of the Chair at our meetings during the coming year to acknowledge the. presence of past presidents. In particular, I would like to thank my four predecessors, Richard A. Rossman, Sheldon S. Toll, Paul D. Borman and especially Robert P. Hurlbert, for preparing me for this year.

After the election is perhaps a somewhat strange time to reveal my program for the year to you. To the best of my recollection, our bylaws do not include a provision for recall of the President. My three membership objectives all have to do with encouraging more active participation by women, minorities and government lawyers.

The officers and executive board say jokingly that the Detroit Chapter has become the U.S. District Court Admiration Society. I want you to know that I am sensitive to this point and realize my presence in the Chair places me in a continuing position of potential conflict. For the last year or two I have been exercising extreme caution when talking with lawyers to advise them whether I am "wearing my District Court Executive hat" or "my Federal Bar Association hat". I am also aware that the extremely close ties between the Chapter and the District Court have also, perhaps along with the increased dues and the increasing costs of luncheon and dinner meetings, caused estrangement of many government lawyers whose work has little or no contact with the District Court. It might come as a surprise to many of our members to know that in most cities Federal Bar Association chapters consist almost exclusively of government lawyers. I believe it is one of the great strengths of our Chapter that we have such a broad cross-section of lawyers

including many who have never been government lawyers and many more who have left government law offices for private practice. But, I also believe we need to make membership and activities more attractive to government lawyers. For this reason, I will work with other Chapter presidents in opposing a proposed increase in the national FBA dues from \$48 to \$85.

The recruitment of women members will be an expanded concern of the Membership Committee. I am writing to the President of the Women Lawyers Association of Michigan and the presidents of their regional chapters inviting their membership to join and participate more actively in the Federal Bar Association. It is hoped that our first speaker on October 23, Deputy Assistant Attorney General Victoria Toensing, will be of interest to a broad spectrum of lawyers including both our current membership and those who might be interested in membership.

Anthony Adams, Assistant to Mayor Coleman A. Young and a former Executive Board member of the Detroit Chapter, has accepted appointment as co-chair of the Membership Committee. Anthony and I have discussed, and Anthony will keep the Executive Board informed of, ways in which our organization can be more attractive and useful to minority lawyers.

Along with all of the foregoing, we hope to maintain, and even perhaps improve upon the high standards we have set in the. past in the New Lawyers Seminar, Trial Advocacy Workshop and the substantive programs put on by our several sections (Bankruptcy, Civil Law, Criminal Law, EEO/Labor Law and Taxation).
