JUDGE THORNTON PORTRAIT CEREMONY

The portrait of the late Judge Thomas P. Thornton by Patricia Hill Burnett has been completed, and Friday, May 29, 1987 has been selected as the date for the unveiling and hanging of the portrait. The ceremony will take place in Room 861, the courtroom where Judge Thornton presided for more than 36 years. A reception will follow. The portrait was made possible by gifts from judicial officers, law firms, individual attorneys and members of the public whose contributions will be acknowledged in the ceremony program which will feature a full-color reproduction of the portrait.

JOHN REED DELIGHTS THE MULTITUDE

Mixing humor and philosophy in almost equal parts, Professor John W. Reed addressed a Detroit Chapter luncheon on Thursday, February 26, 1987. His topic was "Interesting Times." The title, he reminded us, comes from the old Chinese curse: "May you live in interesting times." He went on to say: "These <u>are interesting times; but whether that</u> is a curse depends mostly on you, not on the events. I'm no philosopher, but I suppose I express a kind of existentialism when I say that what happens to us is not what makes the difference. What makes the difference is how we respond to what happens." Further showing his affinity for Chinese thought, both ancient and modern, Professor Reed spoke of the man who opened his fortune cookie and read the message: "A change for the better will be made against you." In this vein, he discussed three developments in the law which, he said, come under the heading of changes for the better that are being made against the legal profession: tort reform, "the steady, almost unremitting attack on the jury" and increasing emphasis on making the practice of law more businesslike.

PRO BONO PANEL NEEDS TRANSFUSIONS

The Pro Bono Assignment Panel for the Eastern District of Michigan is once again in need of new blood at all levels (committee, advisory panel and attorneys willing to take assignments). After more than a year and a half during which time the supply has equaled or exceeded the demand, danger signs are popping up more and more frequently in the form of attorney burn-out and increasing requests to withdraw from the Panel. As has been stated since the very beginning in 1983, the Panel cannot function fairly unless there are enough attorneys so that no one receives more than one, or at the most two, assignments per year. Also needed are experienced pro bono attorneys willing to put in some additional time on the FBA committee which works closely with the District Court committee chaired by Judge Julian Abele Cook, Jr. and the Advisory Panel consisting of attorneys experienced in employment discrimination and prisoner civil rights law who make themselves available to panel attorneys for consultation and guidance at various phases in assigned cases.

ICM PRESENTS BATSON WORKSHOP

The Institute for Court Management is presenting a workshop on "Dealing with Racially Motivated Peremptory Challenges" at the Southfield Hilton on Friday, May 15, 1987. In Batson v. Kentucky, the U.S. Supreme Court held that the prosecutors' peremptory challenges of prospective jurors based solely on racial grounds violated the equal protection rights of both the defendant and the excluded jurors. In his dissent, Chief Justice Warren E. Burger recognized that implementation of this decision may present some difficulties and observed, "I join my colleagues in wishing the nation's judges well as they struggle to grasp how to implement today's holding." This workshop is designed to help not only judges but prosecutors and defense attorneys understand what is required by the <u>Batson</u> holding and how it can be implemented. The workshop will be very practical in its orientation. The faculty will include Judge Spurgeon Avakian, Superior Court, Alameda County, California; G. Thomas Munsterman, Director, Center for Jury Studies of the National Center for State Courts; Richard A. Williamson, Vice Dean and Professor of Law, Marshall-Wythe School of Law, College of William and Mary, Williamsburg, Virginia. Registration and tuition (received by April 27, 1987) is \$145; after that date tuition is \$160. The fee includes a luncheon, morning and afternoon refreshments, and a workshop notebook and other materials.
