

## IMPEACHMENT OF FEDERAL JUDGES TO BE TOPIC AT RAKOW AWARDS LUNCHEON ON NOVEMBER 12, 1992



The Detroit Chapter is pleased to announce that Wayne State University Law Professor Robert Sedler will speak on the topic, "Impeachment and the Political Question Doctrine" at the November 12, 1992 Rakow Luncheon. Professor Sedler will analyze and discuss the legal issues presented in Hastings v U.S. and Nixon V. U.S., which concern the impeachment and conviction of two federal judges. Nixon is pending in the United States Supreme Court.

# PROPOSED BYLAW AMENDMENTS TO BE CONSIDERED AT NOVEMBER LUNCHEON MEETING

The Board of Directors unanimously approved recommending the following bylaws amendments. These proposed amendments do not reflect any substantive change but rather are for the purpose of making the Detroit Chapter's Bylaws consistent with actual practice. For purposes of considering these amendments, the November 12, 1992 luncheon meeting at the Westin Hotel shall be considered a special meeting and notice is hereby given that the following proposed amendments will be considered at that time.

## ARTICLE I - NAME AND CONSTITUTION

This organization shall be known as the Detroit Chapter of the Federal Bar Association. The Constitution of the Federal Bar Association as it may be amended, from time to time, is hereby adopted and incorporated herein by reference insofar as it may be applicable to the business of this Chapter and ~~shall prevail over these Bylaws in event of conflict therewith.~~ However, in the event of conflict, these Bylaws shall prevail over the Constitution of the Federal Bar Association.

## ARTICLE III - MEMBERSHIP

### Section 3 - Application for Membership:

Application for membership in this Chapter shall be made on a form approved by the ~~National Council~~ Detroit Chapter of the Association. Each application must be accompanied by the dues and admission fees required by the Constitution and Bylaws of the Association and the Bylaws of the Chapter.

### Section 6. Dues:

Dues owing to the ~~Federal Bar Association nationally and to the Detroit Chapter~~ shall be collected by the ~~respective~~ Treasurers of the ~~Federal Bar Association and the Detroit Chapter.~~ The Chapter share of National dues are automatically provided by Bylaw 2 of the Association at the rate of \$7.50 for senior members and \$3.00 for junior and retired members and such amounts shall be collected by the Treasurer of the Detroit Chapter. In accordance with the provision in that Bylaw, ~~T~~he Detroit Chapter Treasurer shall collect ~~has an additional amount of annual dues in the amount of \$10.00 for senior members, and \$5.00~~ \$10.00 for junior members (admitted to the bar less than 5 years), \$15.00 for regular members and \$50.00 for sustaining members.

ARTICLE V - OFFICERS:

Section 2.

Each officer elected shall assume the duties of his office on ~~July~~ June 1, shall hold office for one year and shall perform such duties as designated by the Executive Board. No member serving in the capacity of President or Vice President shall be eligible to succeed himself or herself in the respective office. The outgoing President shall remain a member of the Executive Board for a period of one year following the expiration of his or her term of office as President.

Section 5. Elections:

The election of officers for all elective offices shall be by secret ballot or by voice vote. The election shall be held during the annual meeting. The officers elected shall commence their term of office on ~~July~~ June 1 of each year and shall hold office for one year ending ~~June~~ May 30.

Section 8. Indemnification

The Chapter shall indemnify any person who is or was a director or officer of the Chapter, or who is or was serving at the request of the Executive Board of the Chapter as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise to the full extent permitted by the laws of the State of Michigan as in effect from time to time, and, upon resolution of the Executive Board of the Chapter, the Chapter may indemnify such other persons as designated from time to time by the Executive Board to the full extent permitted by the laws of the State of Michigan as in effect from time to time.

## **BANKRUPTCY COMMITTEE TO CO-SPONSOR SEMINAR ON CURRENT ISSUES IN BANKRUPTCY LAW AT U. OF M. LAW SCHOOL.**

On November 17 and 18, 1992, the Bankruptcy Committee will be co-sponsoring a conference discussing current bankruptcy questions. Of special interest is the panel discussion to be held on November 18, 1992, on the desirability of scraping Chapter 11. The panel will include Professor Michael Bradley and Michael Rosensweig, co-authors of the recent article "The untenable Case for Chapter 11", published in the March, 1992 volume of the Yale Law Journal. Rebutting their critique of Chapter 11 will be Prof. Lynn Lopucki. The conference will take place at the University of Michigan Law School. Both sessions will begin at 1:30 p.m. A cocktail party will follow the panel discussion on November 18. Bankruptcy Section members should look for a mailing on the conference in the next week. ## **BANKRUPTCY COMMITTEE HOSTS RECEPTION FOR BANKRUPTCY JUDGES**

The Bankruptcy Committee opened the 1992-1993 year with a reception for the Bankruptcy Judges of the Eastern District of Michigan in September, 1992. Judge Rhodes, Judge Spector and Judge Shapero were present. Over seventy practitioners attended the reception, which was hosted by Miller, Canfield, Paddock & Stone on the terrace of their offices located at 150 W. Jefferson Ave., Detroit Mi. The reception gave practitioners the opportunity to chat informally with the judges and to socialize outside the sometimes frenzied and contentious halls of the Bankruptcy Court.

Co-Chairs Julia Caroff, Assistant United States Attorney, and Michael Traison, of Miller, Canfield are planning a number of events that should be of interest to bankruptcy lawyers. On November 17 and 18, 1992, the Committee is co-sponsoring a conference on current bankruptcy questions with the University of Michigan Law School. Tentatively scheduled are a series of lunches, at which, one of the Bankruptcy judges will be the featured speaker.

## **GREATER REBATES SOUGHT FROM NATIONAL**

### **RESOLUTION**

NOW, THEREFORE, BE IT RESOLVED that Bylaw Number 4, be amended to Read: "Twenty-Five percent (25%) of each member's and associate's dues, rounded upward to the next one-half dollar, shall be rebated to the Chapter that serves the location of the member's or associate's mailing address.
