GRAND TRAVERSE BAND CHIEF JUDGE MICHAEL PETOSKEY TO ADDRESS FEBRUARY 18th LUNCHEON

The Detroit Chapter will welcome Grand Traverse Band of Ottawa and Chippewa Indians, Chief Tribal Judge Michael Petoskey as the speaker at the February 18, 1993 luncheon. Judge Petoskey will speak on Native American Tribal Courts and Contemporary Legal Issues. This will be a patricularly timely topic with the recent interest in casino gambling and the publicity regarding the Stephanie Gray custody case. (That is the case where a Macomb County Circuit Judge agreed that the Indian Tribal Court and not the State Court, had jurisdiction to decide whether the child's grandmother or father should have custody.)

Tribal Judge Petoskey is the trice-great-grandson of the Ottawa Chief Pe-Taw-Se-Gay, a signatory of the 1985 Treaty of Detroit that reversed the federal policy of removing Michigan Indians from their aboriginal territory to land west of the Mississippi. At the time he was born in "Indian Town" Harbor Springs, the Native Americans of Northwestern Michigan were essentially landless, having lost their land through one sided treaties and the reversion of land to the State for non-payment of taxes from which they should have been exempt. Although coming from an impoverish background, he excelled in high school and after serving in the Army including a tour of duty in Vietnam, he graduated from Michigan State University. After working for a period of time, he was eventually able to attend and graduate from the University of New Mexico's American Indian Law Center. He returned home as a staff attorney for Michigan's Indian Legal Services of which he became executive director in 1987. Judge Petoskey has served as Chief Judge of the tribal court since 1988. He is also presently director of NMC's Native American and Minority Services Program.

This past year, the Michigan Supreme Court appointed a seven-member State Court/Tribal Court Forum to explore the relationship between tribal and state justice systems in Michigan. Michael Petoskey is vice-chair of this committee which recently submitted its plan to the Supreme Court, aimed at improving cooperation.

THE LEONARD R. GILMAN AWARD

The Leonard R. Gilman Award was established by the Detroit Chapter of the Federal Bar Association in 1985 in memory of Leonard R. Gilman who, at the time of his death on February 12, 1985, was the United States Attorney for the Eastern District of Michigan. The award is presented annually at a Chapter Luncheon to "an outstanding practitioner of criminal law" amplifying the qualities that "Lenny" possessed.

The following are the criteria to apply in selecting the Gilman Award recipient:

- 1. The recipient attorney should be significantly engaged in the practice of criminal law.
- 2. The Recipient should exemplify the qualities that distinguished Leonard R. Gilman. They include:
 - a. <u>Integrity</u>. The recipient should demonstrate throughout his/her career a high and consistent level of professional integrity.
 - b. Fairness. The recipient should demonstrate throughout his/her career a consistent sense of fair play in his/her dealings with the court and opposing counsel.
 - c. Excellence. The recipient should demonstrate a high level of competency and professional skills both in and out of the courtroom.
 - d. Zealous Advocacy. The recipient should be a zealous advocate of his/her clients interests, consistent with fair play and the Rules of Professional Conduct.

The Selection Committee is chaired by the President of the Detroit Chapter of the FBA and composed of all past award recipients.

THE BANKRUPTCY SECTION SPONSORS SYMPOSIUM AND LUNCHEONS

It has been a busy year for the Bankruptcy Section. On November 16, 1992, the Honorable Arthur J. Spector United States Bankruptcy Judge, spoke on "Chapter 11A Proceedings" at a luncheon at Mario's.

On November 17 and 18, 1992, the Bankruptcy Section co-sponsored with the University of Michigan School a symposium on proposed changes to the Bankruptcy code. Among the highlights were a panel discussion between Michael Rosensweig and Professor David Brandley, authors of a recently published article in the Yale Law Review, advocating the abolition of Chapter 11, and Prof. Lynn Lopucki, a critic of their proposals. Other featured speakers were the Honorable Stephen Rhodes, United States Bankruptcy Judge for the Eastern District of Michigan and Attorney Bob White, currently debtor's counsel in the Phar-Mor bank-The panel discussions on ruptcy. November 18, 1992, were concluded with a cocktail party at the law school.

ATTORNEYS NEEDED FOR SOCIAL SECURITY CLAIMANTS REFERRAL SERVICE

The Detroit Chapter is setting up an attorney referral service for social security disability claimants who wish to be represented by a private attorney. Numerous claimants who file a claim at the administrative level are not represented by attorneys. These claimants receive a letter listing lawyer referral organizations. Starting approximately February 1, 1993, the FBA Detroit Chapter Referral Service will be added to the short list of referral services sent to all unrepresented claimants filing claims with the Detroit Office of Hearings and Appeals. If an attorney prevails in these cases, the attorney fee is the lesser of 25% of past due benefits or \$4,000.00 and the money comes directly from the United States. In 1990, ALJ's awarded benefits in 63% of the cases.

The requirements for being on the referral list are that the attorney be a member of both the National FBA and the Detroit Chapter, that a copy his/her malpractice insurance policy showing policy limits and effective dates be provided and that the attorney request in writing to be on the list. OPEN LETTER FROM CHIEF JUDGE COOK

Dear Attorney:

I write to ask you to help the United States District Court meet a very important need. The Court is in great need of volunteers for the Eastern District's <u>ProBono</u> Civil Assignment Panel to handle employment discrimination and prisoner civil rights cases in which the plaintiff has filed in propria persona.

These cases frequently raise meritorious issues, but without counsel to prepare them for trial or settlement, they are difficult to resolve and justice may not be done. Nor is it fair that only a few members of the bar in the Eastern District step forward to assist the Court with these cases — all members of the bar should offer some of their time and expertise to help handle these cases.

In addition to assisting the Court, these cases can provide you with valuable "hands-on" litigation and courtroom experience, and your work on them can help you satisfy the State Bar's new recommended pro bono standards.

The Eastern District has sought to make taking these cases as easy as possible: up to \$500.00 in expenses are reimbursable; pro bono court reporter services may be available; professional liability insurance of \$1,000,000.00 has been obtained for all pro bono attorneys and their firms; educational materials and consultation with attorneys knowledgeable in the field are available; and pro bono attorneys are not expected to handle appeals, if any.

Your commitment to participate in the pro bono assignment system is essential to its long-term success. Only a sharing of this responsibility among all lawyers in the Eastern District will prevent a breakdown of the system in the future. If, as in the past, the Court must continue to look to a few attorneys to shoulder this responsibility, the system will ultimately fail and the adversary system will be compromised.
