## HONORABLE MARVIN E. ASPEN TO ADDRESS RAKOW AWARDS LUNCHEON ON DECEMBER 2, 1993

The Detroit Chapter of the FBA is pleased to announce that United States District Judge for the Northern District of Illinois, The Honorable Marvin E. Aspen will address the Chapter at its annual Rakow Awards Luncheon on Thursday, December 2, 1993. Judge Aspen will speak on how to effectively promote civility in litigation. For the past four years Judge Aspen has served on the Seventh Circuit Committee on Civility. That committee was the first to make a Federal circuit-wide inquiry and study of the matter. Judge Aspen, a renowned and frequent lecturer and trial advocacy instructor, will share his considerable knowledge on this important topic which includes proposed standards for judges and attorneys.

#### REPORT ON NATIONAL ETING: DETROIT CHAPTER AND PAST PRESIDENT HALLIDAY HONORED

In early October, Chapter President Ed Kronk and Immediate Past President/ newly elected Sixth Circuit Officer Geneva Halliday attended the FBA National Meeting in New Orleans. Each year at the awards luncheon the national organization presents Chapter Activity Awards to one chapter in each of four groups. The Detroit Chapter is in Group I which includes all of the large Chapters around the country. The Chapter Activity Award recognizes outstanding work and accomplishments by one Chapter in each group. Based on its outstanding performance during the 1992--93 year, the Detroit Chapter was awarded the Group I Chapter Activity Award for 1993. Additionally, Geneva Halliday, under whose leadership the Chapter won the Activity Award, was singled out for a Special Recognition Award presented by FBA National President Malcolm Monroe for her tireless efforts on behalf of the Association. Congratulations to Geneva. Both awards will be hung in the attorney conference room in the Federal Courthouse.

The issue of increasing the portion of national FBA dues that is rebated to local chapters was on the agenda for the October meeting and generated spirited debate. Currently 15% of national dues are rebated to the locals. A resolution sponsored by the Detroit Chapter urged that the organization increase the rebate to 25%. Leadership of the national organization vigorously opposed the proposal, arguing that it would compel drastic reduction of national activities and programs. They proposed, as an alternative, that a "Chapter Activity Fund" be established to support activities by local chapters. Chapters could tap into the fund by applying in connection with specific programs. After lively discussion, the 25% proposal was defeated and the Chapter Activity Fund was pass ed. In response to pressure from the increased rebate proponents, it was agreed that the matter would be revisited next year. We are confident that the issue of increased rebates is not dead. Stay tuned.

## BANKRUP JY JUDGE SPECTOR ADDRESSES FLINT LUNCHEON

Continuing its tradition of active programming for bankruptcy practitioners, the Bankruptcy Section of the Detroit Chapter, in conjunction with the newly formed Flint Section, hosted a luncheon on Thursday, November 4, 1993. The Honorable Arthur J. Spector, U.S. Bankruptcy Judge for the Eastern District of Michigan, addressed some 40 practitioners on "Preferential Classification of Educational Loan Debts in a Chapter 13 Plan". Judge Spector's remarks were well received and the luncheon provided an excellent exchange opportunity for bankruptcy practitioners in the Detroit and Flint areas.

## THE LEONARD R. GILMA AWARD NOMINATIONS SOLICITED

The Leonard R. Gilman Award was established by the Detroit Chapter of the Federal Bar Association in 1985 in memory of Leonard R. Gilman who, at the time of his death on February 12, 1985, was the United States Attorney for the Eastern District of Michigan. The award is presented annually at a Chapter Luncheon to "an outstanding practitioner of criminal law" amplifying the qualities that "Lenny" possessed.

The following are the criteria to apply in selecting the Gilman Award recipient:

- 1. The recipient attorney should be significantly engaged in the practice of criminal law.
- 2. The Recipient should exemplify the qualities that distinguished Leonard R. Gilman. They include:
  - a. Integrity.
    The recipient should demonstrate throughout his/her career a high and consistent level of professional integrity.
  - b. Fairness.
    The recipient should demonstrate throughout his/her career a consistent sense of fair play in his/her dealings with the court and opposing counsel.
  - c. Excellence. The recipient should demonstrate a high level of competency and professional skills both in and out of the courtroom
  - d. Zealous Advocacy. The recipient should be a zealous advocate of his/her clients' interests, consistent with fair play and the

Rules of Professional Conduct.

The Select on Committee is chaired by the President of the Detroit Chapter of the FBA and composed of all past award recipients.
