1994 GILMAN AWARD TO BE PRESENTED TO MIRIAM SIEFER

The Detroit Chapter of the Federal Bar Association is pleased to announce that Miriam L. Siefer is the recipient of the 1994 Leonard R. Gilman Award.

Ms. Siefer attended college at the University of Michigan and graduated Cum Laude in 1975. After three years in private practice, Ms. Siefer taught at Wayne State University Law School and was director of the Criminal Advocacy Clinic in 1979-1980. Since May of 1980, Ms. Siefer has served on numerous committees including the Sixth Circuit Pattern Criminal Jury Instruction Committee and the Eastern District of Michigan Federal Court Rules Committee. Ms. Siefer presently serves as a Vice President of Criminal Defense Attorneys of Michigan.

The Leonard R. Gilman Award is awarded annually to an outstanding practitioner of criminal law who exemplifies the qualities that distinguished Leonard R. Gilman, including integrity, fairness, excellence and zealous advocacy.

LOCAL RULES UPDATE

On February 7, 1994 the Chief Judge entered Administrative Order 94-A0-019 which superseded Administrative Order 93-A0-092. The earlier order had deferred applicability of Rule 26(a) to cases filed in the Eastern District "before April 1, 1994, or until further order of the court". The February 7, 1994 Administrative Order provides:

The provisions of Fed. R. Civ. P. 26(a) (1) concerning initial disclosures required by Rule 26(a) (1) may be directed by any Judge by order entered in a particular case.
