Judge Cornelia Kennedy To Speak At Rakow Awards Luncheon

The FBA will hold its annual Rakow Awards Luncheon on Tuesday, November 9, 1999 at the Crowne Plaza Ponchartrain Hotel. The luncheon will be co-hosted by the Historical Society for the United States District Court, which also hold its annual meeting at that time.

Judge Cornelia Kennedy of the United States Court of Appeals for the Sixth Circuit has kindly agreed to reminisce with us about her experiences with the district and circuit courts. Judge Kennedy was appointed to the Eastern District in October of 1970 and became Chief Judge in January of 1977. She left in 1979, after being appointed to the Sixth Circuit, where she now sits. Given her long standing association with these two institutions, her talk will be most interesting and worthwhile.

1999 State of the Court

The Eastern District of Michigan Chapter of the Federal Bar Association hosted its annual State of the Court Luncheon on September 16, 1999 at the Crown Plaza Pontchartrain Hotel. The Honorable Lawrence P. Zatkoff, Chief Judge of the United States District Court for the Eastern District of Michigan delivered the State of the Court Address. Judge Zatkoff reported that the composition of the court "has changed substantially" over the past year, beginning with his appointment as Chief Judge on January 1. David J. Weaver became the new Court Administrator upon John Mayer's retirement in July. Judge Robert E. DeMascio lost his battle with cancer in March and Judge Horace W. Gilmore retired in October.

President's Column

"Injustice anywhere is a threat to justice everywhere."

-Martin Luther King, Jr. Letter from the Birmingham Jail

In my last column, I wrote about the fundamental duty of lawyers and associations of lawyers to protect the public, and how all of our activities as a bar association are guided by that duty.

A critical part of our duty as lawyers to protect the public is to ensure that the public is served by a legal system free from bias, real or perceived. We must be vigilant to detect and stop any discriminatory treatment within the legal system because nothing is more corrosive of respect for our legal system than the perception or reality that the quality of justice depends on one's race, gender, ethnicity or other personal characteristics. The Reverend Dr. Martin Luther King, Jr. was so insightful when he trenchantly observed from the Birmingham, Alabama jail that any injustice tears at the entire fabric of justice.

As part of a profession whose very purpose is to seek justice, we are all vigilant everyday as we practice law to insure that we brook no discriminatory treatment in the operation of the legal system. However, beyond the necessary individual vigilance of judges and lawyers, what can we do as an association of lawyers to protect the integrity of the legal system from the dangers of discrimination? Plenty, and we are taking action as an association.

Inspired by the excellent work of the State Bar of Michigan's 1996-97 Task Force on Racial/Ethnic and Gender Issues in the Court and the Legal Profession (appointed by then–State Bar President and now Judge Victoria Roberts, and Co-Chaired by U.S. Attorney Saul Green), and by similar efforts in several other federal circuits (e.g., the D.C., 2d, 3d, 8th and 9th), the Executive Board decided last year to survey the judges, and the attorneys in the U.S. Attorney's Office, Federal Defender's Office and in our member-

ship to determine whether such issues exist in the Eastern District of Michigan.

Our Chapter's liaison to the State Bar Task Force on Race/Ethnic/Gender Issues, Deborah Gordon, has worked very hard to craft questionnaires for judges and for attorneys, taking advantage of the experience of the circuits which have already surveyed their judges and attorneys.

Those questionnaires will soon be mailed. While the response is entirely voluntary, I ask you to take the time to carefully and thoughtfully complete it and return it because the quality and quantity of responses are critical to the survey's value.

Once the questionnaires are returned, Deborah Gordon and a committee will tabulate and provide a preliminary report on the results to the officers and Executive Board. The Board will then decide how to proceed. We will proceed thoughtfully, weighing the results, listening to all points of view and reaching considered conclusions.

Attorney General Robert Kennedy once noted that the "enemies of [achieving equality] are not the black man or the white man. The enemies are fear and indifference. They are hatred and, above all, letting momentary passion blind us to a clear and reasoned understanding of our land." This survey is part of our effort to reach a "clear and reasoned understanding" of whether there are issues of race, gender or ethnic bias in the Eastern District with which we must grapple. I ask for your help in this important effort.

(State of the Court cont'd from page 1) year, civil case filings decreased by 13% and criminal case filings decreased by 17%.

With the new millennium approaching, Judge Zatkoff was pleased to announce that all locally supported court applications are Y2K compliant. He also reported several technological advances within the court system. These include a court website, where recent efforts in posting judges' opinions at the site have been well received. The court has also established videoconferencing between Detroit and Bay City and has been selected to participate in a program for videoconferencing in prisoner civil rights cases. The court recently implemented a new automated Jury Management System. A new electronic case management system, with the capability for electronic filings over the Internet, is also on the horizon.

Judge Zatkoff also thanked the members of the Merit Selection Panel and Local Rules Advisory Committee for their service to the court.

Judge Zatkoff concluded his address by stating his belief that even more "distinctive challenges and issues are down the road."

The Federal Bar Association also recognized those individuals who have contributed to the succes of the nationally recognized New Lawyers Seminar.

Judge Cohn Takes Senior Status

On October 9, 1999, United States District Judge Avern Cohn took senior status pursuant to 28 U.S.C. § 371, which allows a judge who meets certain age and years of service requirements to retire from regular active duty but continue to serve as a United States District Judge. Judge Cohn's retirement to senior status comes after 20 years of service as an active district judge, following his appointment by President Jimmy Carter in 1979. Prior to his appointment, Judge Cohn, who received his J.D. from the University of Michigan in 1949, was in private practice at the law firm Honigman, Miller, Schwartz, and Cohn. Although Judge Cohn is now permitted to take a reduced caseload, he plans on maintaining a full docket at this time.

Recent Nominees to Federal Bench

On September 16, 1999, President Clinton nominated Detroit attorney Kathleen McCree Lewis to the U.S. Court of Appeals for the Sixth Circuit. Ms. Lewis has been affiliated with Dykema Gossett PLLC first as an associate and then as a partner since 1973. She received her B.A. from the University of Michigan in 1969 and her J.D. from the University of Michigan Law School in 1973. Ms. Lewis is Dykema Gossett's appellate litigation specialist. In addition to her numerous professional and civic activities she is a director of Jacobson's Stores, Inc., a trustee of the Center for Creative Studies, and a director of the Community Foundation for Southeastern Michigan. She is a former Commissioner of the City of Detroit Civic Center Commission and a past trustee of Children's Hospital of Michigan, Children's Museum Friends and the Grosse Pointe Academy.

Ms. Lewis and her husband jointly received the 1995
Learned Hand Award from the Detroit Chapter of the
American Jewish Committee Institute of Human Rights for
their civic, educational and philanthropic endeavors. In
1997, in a joint project of Crain's Detroit Business and the
Michigan Women's Foundation, she was named one of
Detroit's Most Influential Women. Ms. Lewis lives in
Detroit with her husband, David Baker Lewis, who also is
lawyer. They have two children, Aaron, a 1999 graduate
of Princeton University, and Sarah, a student at Stanford
University.

On August 5, 1999, President Clinton nominated David

M. Lawson and Marianne O. Battani to the U.S. District Court for the Eastern District of Michigan. David M. Lawson, of Troy, Michigan, has been a member of Clark Hill PLC since 1994. Prior to joining Clark Hill PLC, Mr. Lawson was a partner at Lizza, Mulcahy, Casey & Lawson from 1985 to 1994 and served as a Special Livingston County Prosecuting Attorney from 1991 to 1993. He also was a partner at Lawson & Lawson PC from 1977 to 1985 and served as a Special Assistant Attorney General from 1978 to 1980. Since 1977, he has been a member of the faculty of the Michigan Judicial Institute and has lectured extensively on evidence and procedure to judges and lawyers throughout the country. He has served as a law clerk for Oakland County Circuit Court Judge John N. O'Brien and as an Investment Officer for Oakland County Treasurer C. Hugh Dohaney. Mr. Lawson received his B.A., magna cum laude, in 1972 from the University of Notre Dame and his J.D., magna cum laude, in 1976 from Wayne State University Law School (graduating first in his class). Following law school, Mr. Lawson served as a law clerk to the Honorable James Ryan on the Michigan Supreme Court from 1976 to 1977. He resides in Troy and is the father of three

Marianne O. Battani, of Grosse Pointe Woods, Michigan, has been a Judge on the Wayne County Circuit Court since 1982. Prior to her appointment to the Wayne County Circuit Court, Judge Battani sat on the 36th District Court for the City of Detroit from 1981 to 1982 and on the Common Pleas Court for the City of Detroit in 1981. In addition, she practiced law in the Law Office of Marianne O. Battani from 1974 to 1981, and from 1972 to 1974 as an Associate Attorney in the Law Offices of Donald E. Gratrix. In addition to her work on the bench, she has taught courses for the Michigan Judicial Institute and the National Judicial College in Reno, Nevada. She received her B.A., cum laude, in 1966 from the University of Detroit, and her J.D., cum laude, in 1972 from the Detroit College of Law. She lives in Grosse Pointe Woods and has one daughter.

Portrait Foundation Facilitates Judicial Remembrances

The Judicial portraits that hang in the Theodore Levin Courthouse are an important part of the maintenance of a historical record of the United States District Court for the Eastern District of Michigan. Portraits, however, are not sponsored by or funded by the government, and the commissioning and funding of them is an expensive and time-consuming process.

In October of 1997, after extensive study and planning by local members of our Chapter and former judicial law clerks, the Eastern District of Michigan Historical Portrait Foundation was established as an independent non-profit corporation in order to facilitate the process by providing seed money and guidance to committees that undertake fund-raising and coordination of individual portraits. Shortly after the Portrait Foundation was formed, it obtained status as a freestanding IRC 501(c)(3) tax-exempt entity.

Now, upon formation of a portrait committee (generally by an eligible judge's former law clerks) our Chapter donates \$1,500.00 to the Portrait Foundation. The Portrait Foundation provides the particular portrait committee with an initial grant which funds the solicitation of additional contributions. Contributions, which are made payable to and disbursed by the Portrait Foundation, are solicited strictly in accordance with any limitations imposed by the eligible judge. Due to the Portrait Foundation's IRC 501(c)(3) status, contributors are permitted to claim a charitable deduction in the amount of their contribution. If fund-raising is completed within twelve months, the balance of the \$1,500.00 grant is provided to the committee to help defray additional costs, including the presentation ceremony. The process is complete upon the submission of a written report of finances and activities which the portrait committee provides to the Portrait Foundation.

Consistent with local court rules, District Court Judges of the Eastern District of Michigan are eligible for a portrait upon full retirement from the Bench and the practice of law, or upon death. Committees for Sixth Circuit judicial portraits of former Eastern District of Michigan judges may utilize the Portrait Foundation, but are not provided seed money.
