Passing of the Gavel to New Chief Judge Denise Page Hood

On January 1, 2016, Denise Page Hood became Chief Judge of the U.S. District Court for the Eastern District of Michigan. She originally was appointed by President Bill Clinton and confirmed by the Senate in 1994.

The "Passing of the Gavel" ceremony was held on January 28. Circuit Judge Damon J. Keith, with whom Judge Hood interned when he was Chief Judge of the Court, administered the oath of office. The ceremony was witnessed by over 700 individuals in the ceremonial and several

overflow courtrooms. Chief Judge Hood's guests included her family, church members, friends, classmates from her high school and college, current and former staff members, the Court family, attorneys, elected officials, and federal and state judges. This was a tribute to Chief Judge Hood's nature of being inclusive and welcoming to all.

Chief Judge Hood's belief in inclusiveness and access to the courts by all is reflected in her work within the legal

U.S. Courts and this Court's Local Rules and Criminal Rules committees.

Chief Judge Hood's legal experience began as an assistant corporation counsel with the City of Detroit and then as a judge with 36th District Court, Recorder's Court, and Wayne County Circuit Court. She served as president of the Detroit Bar Association and the Association of Black Judges of Michigan. Chief Judge Hood brings different perspectives from her activities outside the legal community -- as a member of the Olivet College Board of Trustees, the Harper-Hutzel Hospital Board of Trustees, the InsideOut Literary Arts Project Board, and other literary and service clubs in Detroit.

Because of their support throughout her career, it was important to

Chief Judge Hood that her church members from Plymouth United Church of Christ attended the ceremony. Her husband, Rev. Nicholas Hood, III, is the senior minister of PUCC. Chief Judge Hood is active at PUCC as a member of the Board of Christian Education, the Intergenerational Women's Dialogue Committee, Bible Study and Summer Sunday School teacher.

She served on the UCC national church sitting as Moderator and Chair of the Executive Committee, and as General Synod Parliamentarian. With her local church, she has traveled on medical and church missions to South Africa and Ethiopia, and on a bible study tour following the steps of the Apostle Paul through Greece and Italy. As part of the national UCC delegations, Chief Judge Hood participated in anniversary celebrations of partner churches in Zimbabwe and Ghana.

In 1993, she traveled with a UCC delegation to Hawaii to make a formal public apology to the Native Hawaiian people for the church's role and complicity in overthrowing the Kingdom of Hawaii in 1893. Chief Judge Hood and her husband were invited to Silliman University, a UCC-related college, in the Philippines, where she presented at the Law School and her husband at the Divinity School.

Chief Judge Hood has received numerous honors throughout her career. The more recent awards include the 2016 Damon J. Keith Soul

and Spirit Humanitarian Award and the D. Augustus Straker Bar Association's 2014 Trailblazer Award. She is honored and humbled to be the fourth African American and third woman Chief Judge of this Court.

As she acknowledged at the ceremony, Chief Judge Hood would not be who and where she is without her family from Columbus, Ohio. They supported her when she was enrolled at the Columbus School for Girls and as she attended Yale University and Columbia Law School. Her family's support continued when she moved to Detroit where she was welcomed with open arms by her husband's family, the church, and community.

Chief Judge Hood continues daily to make her family and supporters proud in the work she performs within and without the Courthouse walls. In her robe in the courtroom, Chief Judge Hood treats each litigant with dignity and respect. As Chief Judge, she continues and will continue to treat with

respect all that come before her—litigants, attorneys, court employees, colleagues and members of the public.

from the University of Michigan. Charlene R. Gill has served as Chief Judge Hood's judicial assistant for even longer, working for then-Wayne County Circuit Judge Hood and following Judge Hood to the Court.

National Death Penalty Expert to Address Gilman Luncheon

This year's Leonard R. Gilman Award Luncheon will be held on Monday, April 18 at 11:30 a.m. at the Westin Book Cadillac Hotel. The keynote speaker will be Andrea D. Lyon, Dean of the Valparaiso Law School and a national expert on the death penalty.

Dean Lyon was appointed Professor and Dean of Valparaiso University Law School in July 2014. Previously, she was a clinical professor of law, Associate Dean of Clinical Programs, and the director of the Center for Justice in Capital Cases at DePaul College of Law. She received her undergraduate degree from Rutgers University and her law degree from Antioch School of Law. Dean Lyon has defended more than 30 potential capital cases at the trial level and has taken 19 through the penalty phase – winning all 19. In 1990, she founded the Illinois Capital Resource Center and served as its director. In 1995 she joined the University of Michigan Law School as an assistant clinical professor. Since then she has worked for other academic and legal endeavors.

Dean Lyon has authored or co-authored numerous publications, book chapters, and articles, including *Angel of Death Row: My Life as a Death Penalty Defense Lawyer* (2010), *Team Defense* (2014), and *The Death Penalty: What's Keeping it Alive* (2015).

Dean Lyon has received extensive recognition for her work, including the national Legal Aid and Defender Association's Reginald Heber Smith Award for best advocate for the poor in the country, and Operation PUSH's Rev. Dr. Martin Luther King, Jr. and President Lyndon B. Johnson

Dream-Makers Award.

The recipient of the Gilman Award will be honored at the luncheon. This year's recipient is Gerald K. Evelyn. The Gilman Award is given annually to an outstanding practitioner of criminal law who exemplifies the excellence, professionalism, and commitment to public service of Len Gilman, who was the U.S. Attorney for the Eastern

District of Michigan at the time of his death in 1985. The selection is made by prior recipients of the Award, many of whom served with and knew Len.

As I have reported in an earlier article, the Court is in the process of implementing eVoucher, an automated CJA processing and payment system. eVoucher is being

implemented nationally and is based on a system originally developed in the District of Nevada.

Following a few delays, we will be going live with eVoucher on July 1, 2016. The implementation has required a tremendous amount of effort from Court staff who have worked with an ad hoc committee of judges to ensure a smooth transition. Included in the implementation was a fairly comprehensive update to the Court's CJA Plan to account for and allow the use of eVoucher. Court staff and Federal Defender staff will be undergoing training in the new system soon, and panel attorneys will be trained throughout June 2016.

The Flint water problems are being monitored closely by

Chief Judge Hood and the Court overall. The General Services Administration (GSA), which actually owns the Flint Courthouse, has been providing bottled water to everyone working in the Flint Courthouse and for visitors including members of the Bar, litigants, and the public. GSA is in the process of installing water filters at all water sources in the building. This project is almost complete and has been delayed by the high demand for these filters, which are specifically designed to remove lead contamination.

GSA has also been performing regular water testing at all sources in the Flint Courthouse. The testing results are made available to all staff and copies are kept in the Clerk's Office for anyone interested in seeing them. The Court has also hired an independent testing lab to atmosphere.

Senator Levin Keynotes McCree Luncheon and Receives McCree Award

On March 9, the Chapter awarded its 24th Wade

H. McCree, Jr. Award for the Advancement of Social Justice. Judge Wade H. McCree, Jr., a tireless advocate for social justice, was the first black U.S. Court of Appeals Judge for the 6th Circuit and the second black Solicitor General of the United States. In her first Chapter Luncheon appearance as Chief, Chief Judge Denise Page Hood provided some remarks about Judge McCree. She noted the importance of celebrating his legacy of public service. Chief Judge Hood

was followed by two of the co-chairs of the Social Justice Committee, Cynthia Haffey and Saima Mohsin, who reminded the crowd that nominations for the award are accepted yearround and can be for an individual or an organization.

Judge Paul D. Borman took the podium to introduce this year's recipient and keynote speaker, former Senator Carl M. Levin. As Michigan's longest serving Senator, Senator Levin spoke on behalf of many of the judges of the bench of the Eastern District during their confirmations, including Judge Borman. Judge Borman noted that Senator Levin's "strong vision of government" will be passed on through the newly established Levin Center at Wayne State University Law School. The Levin Center began offering courses in Fall 2015 with a goal of teaching lawyers, legislators, and community leaders how effective legislative oversight can lead to significant and meaningful changes in public policy. In addition to serving as Chairman of the Levin Center, Senator Levin co-teaches a number of courses. acknowledged the influence that Judge McCree's civility, decency, and intellect had on him. Senator Levin noted that in the midst of a presidential campaign season marked with negativity, it is important to be reminded of the good in public service. His remarks focused on an exchange with the late Justice Antonin Scalia.

Senator Levin took the stage to a standing ovation. He

After passage of the Detainee Treatment Act in 2006 precluding detainees at Guantanamo Bay from using habeas corpus, the United States Supreme Court was required to rule on whether the Act deprived it of jurisdiction over a

> pending habeas case from a detainee. See Hamdan v. Rumsfeld, 548 U.S. 557 (2006). The Court held it retained jurisdiction, and Justice Scalia wrote a dissent. In particular, Justice Scalia criticized the Court's reliance on legislative history in determining whether the Act affected pending cases. Having spoken out on the record in the legislative history, Senator Levin took exception to Justice Scalia's criticisms and wrote him a letter.

> True to his character, Justice Scalia responded, even citing the dictionary to support his comments. While Justice Scalia and Senator Levin may have agreed to disagree on the issue, Senator Levin respected Justice Scalia's

"directness." Senator Levin closed by reiterating the importance of Supreme Court justices, who are, after all, public servants, and the impact they have on society.

Diversity Committee Hosts "Day at the Court"

On March 1, the Chapter's Diversity Committee hosted a "Day at the Court," an opportunity for law students to see what they had been learning in school put into practice. The turnout was excellent: more than 30 students from University of Detroit Mercy School of Law, Wayne State University Law School, and Western Michigan University Cooley Law School attended. And for good reason: the students were treated to talks by federal judges, a lunchtime panel of experienced

practitioners and judges, and the opportunity to view live court proceedings.

The day kicked off with an educational tour of the Levin Courthouse led by Barbara Radke with her 40 years of experience at the Court. Three judges then spoke with the diverse group of law students. Executive Magistrate Judge R. Steven Whalen explained the role of magistrate judges in the federal system, including the important task of deciding whether to grant a warrant. District Judge Laurie J. Michelson talked with the law students about a range of topics, including the types of cases that appear in federal court and tips for obtaining a federal clerkship. Magistrate Judge Elizabeth A. Stafford stressed to the students the importance of

developing their research and writing skills and even provided the students with some briefwriting do's and don'ts.

At lunch, students were treated to a panel discussion moderated by Wayne County Circuit Judge Patricia Fresard. Judge Marianne O. Battani spoke about what led her to serve as a federal judge and what she found rewarding about the position. Wayne County Circuit Judge David Allen told

the students that he enjoyed the challenge of being a judge, including very busy motion days.

Students also learned about criminal practice in the federal courts from both sides of the courtroom: Rhonda Brazile spoke about the operations of the Federal Defender Office and Abed Hammoud about those at the U. S. Attorney's Office. Randal Brown informed the students about some of the legal issues handled by the Wayne County Corporation Counsel and what it is like to work there. Also, Adam Wenner, Career Law Clerk to Judge Nancy G. Edmunds, gave the students practical advice on how to obtain a federal clerkship.

In the afternoon, students were invited to view live proceedings. Some attended a suppression hearing before Judge Paul D. Borman. The students were acknowledged by Judge Borman during the hearing and observed an Assistant U.S. Attorney conduct the direct examination of a police officer.

In all, the "Day at the Court" fulfilled its aims: it gave law students insight into what it is like to practice in federal court. The Chapter's Diversity Committee thanks the participating law schools and the many who made the day possible.

Patent Law Seminar For Judges, Law Clerks And Case Managers

On February 2, the Chapter's Intellectual Property

Committee hosted a seminar for judges, law clerks, and case managers that explained patent law principles and best practices for patent infringement cases. Speakers included well known patent law practitioners in the Eastern District, as well as Judge Avern Cohn and Judge Robert H. Cleland.

Thomas Lewry of Brooks Kushman PC presented on basic patent law principles,

including the layout and organization of a U.S. patent, the process by which patents get issued by the United States Patent and Trademark Office, and legal concepts surrounding patent infringement and invalidity.

Christopher G. Darrow of Darrow Mustafa PC, who is frequently appointed a special master and mediator in patent cases, presented on managing a patent infringement case from a judicial perspective. He presented a set of model orders that a judge can use to manage a patent infringement case and discussed the use of a special master in patent cases.

Dean Amburn of Howard & Howard PLLC presented on claim construction hearings and legal principles for construing claims in patents. He presented statistics on claim construction reversal rates at the U.S. Court of Appeals for the Federal Circuit.

A panel consisting of Judge Cleland, Judge Cohn, and John S. Artz of Dickinson Wright, PLLC, discussed various best practices for patent infringement cases, including topics such as (1) using separate technology tutorials as part of the claim construction process, (2) whether to use live testimony at a claim construction hearing, and (3) limiting the number of claims for trial.

New Bankruptcy Local Rules

On January 13, the bankruptcy community came together at a seminar sponsored by the Eastern District of Michigan

Bankruptcy Judges and the Debtor/Creditor **Rights** Committee of the Business Law Section of the State Bar of Michigan to highlight the new local rules for the Bankruptcy Court for the Eastern District. The local rules were last updated in 2009. and the Court and Bar worked tirelessly to update and modernize the local rules, streamlining some of the rules, clarifying others, and conforming the rules to local and national practice. The program was extremely well attended-192 attendees, including speakers-an overflow crowd in Room 115 of the Levin Courthouse.

Access to Bankruptcy Court is an innovative program that has assisted numerous individuals, helping them navigate and process their bankruptcy case in a cost effective, professional manner, and has helped the Court and the Trustees in efficiently administering bankruptcy cases.


