I have received questions regarding the renovation taking place at the Theodore Levin U.S. Courthouse. In a previous article, I mentioned that the

Court has been selected to participate in the Capital Security Program, a project that addresses security improvements in the courthouse. For our court, these improvements include a functional sally port in the basement for secure prisoner transport and major redesigns to both the Lafayette and Fort Street entrances. On the Lafayette side, the new redesign will include wheelchair accessibility ramps. Both new entrances will provide more efficient screening practices and create a more protected queuing space. Construction has finally begun! Inside the courthouse, temporary barricades for construction zones have been set up to allow the contractor to perform demolition but these barricades have no major impact on public space. The construction of the exterior wheelchair ramps began in April and, while the Lafayette entrance will remain open, there may be a minor inconvenience when entering the building. The duration of the project is expected to last between 12 and 18 months. We will keep you informed of impacts to the entrances as the project gets underway.

# **New Lawyers Seminar Recap**By Lauren Mandel

As the Chapter's 48th Annual New Lawyers' Seminar prepared to get underway on January 23 and 24, 2024 in the Detroit Room of the Theodore Levin United States Courthouse, organizers and participants were reminded of an old truth from poet Robert Burns: "The best-laid plans of mice and men often goes awry" (translated). Faced with the impending arrival of a winter weather advisory, including a thick layer of ice, organizers, out of an abundance of caution, moved the first day of programing to Zoom. The program, co-sponsored by the Young Lawyers Section of the Michigan State Bar, moved forward without a hitch.

As it has for the past forty-seven years, the seminar offered new and newer lawyers invaluable and practical advice about practicing in federal and state courts, as well as the opportunity to be sworn in to practice before the federal district court. The first day of the seminar focused on practice in the federal courts and was moderated by Madeline E. Portzline (Hooper Hathaway, P.C.). The first part of the day featured presentations on the

key elements of civil cases, discovery practice, and action under 42 U.S.C. § 1983, as well as informational overviews of electronic filing & PACER, and pro bono opportunities through the federal district court. Speakers included Richard T. Hewlett (Varnum LLP), the Honorable Anthony P. Patti, Angela L. Jackson (Hooper Hathaway, P.C.), Kevin Carlson (Pitt, McGehee, Palmer, Bonanni & Rivers P.C.), Victoria Lung (Data Quality Administrator, U.S. District Court), the Honorable

District Court), the Honorable Kimberly G. Altman, Nolan Moody (Dickinson Wright PLLC), and Jennifer Newby (U.S. Attorney's Office). The morning session concluded with a virtual meet and greet with judges from the federal district court, including District Judges Denise Page Hood, Paul Borman, Laurie Michelson, Linda Parker,

Shalina Kumar, Jonathan Grey, Susan DeClercq, and Brandy McMillion, Chief Magistrate Judge David Grand, and Magistrate Judges Anthony Patti and Kimberly Altman.

The second session featured presentations on the essentials of practicing bankruptcy law, "Tips from the Bench" on motion practice, the "Do's & Don'ts" of practicing in federal court, and the key elements of criminal practice. Speakers included Charissa Potts (Freedom Law, P.C.), Paul Hague (Taft, Stettinius & Hollister), Lauren Mandel

(Career Law Clerk to the Honorable Linda Parker), the Honorable Martha Snow (Wayne County Circuit Court), the Honorable Shalina Kumar, the Honorable Matthew Leitman, Jennifer Newby (U.S. Attorney's Office), Jeffrey Crapko (U.S. Attorney's Office), Adam Wenner (Honigman), the Honorable Laurie Michelson, and George Donnini (Butzel; FBA – E.D. Mich. Chapter President).

With weather issues resolved, the second day of the seminar returned to an in-person format in the federal courthouse and was moderated by Erica Jilek (Miller Canfield). The day began with a trio of representatives from the State Bar of Michigan: Tanya Cripps-Serra, Chairperson of the Young Lawyers Section of the Michigan State Bar (Olympia Entertainment), Michael Goetz, Grievance Administrator with the Michigan Attorney Grievance Commission, and Daniel D. Quick, President of the State Bar of Michigan. Each welcomed the participants to the practice

of law, discussed strategies to balance the many demands new lawyers face, ways to find mentors and other support systems, and the importance of becoming involved in bar activities. Grievance Administrator Goetz discussed common mistakes young lawyers make that end up before the Attorney Grievance Commission, how to avoid making those mistakes, and how to respond to a grievance.

The second day then focused on various state law substantive areas with

speakers providing practical tips gleaned from years of practice. Speakers included Larry Pepper (Law Offices of Larry Pepper) who marked his 30th, and last time, presenting at the seminar on "Practicing in the Michigan Probate & Family Courts," as he also announced

that he will be soon retiring. Other speakers included noted criminal defense attorney Todd Flood (Law Offices of Todd Flood) and Jennifer Grieco, Chair of the Michigan State Bar's ADR Council (Altior Law). Other presentations included: Albert Dib (Jefferson Law Center) on "Evaluating and Litigating Personal Injury Claims," Sam Kokoska (Dawda Mann) on "Basic Michigan Real Property Transactions," Sara Aretakis (Woll and Woll, P.C) on "Handling Domestic Relations Cases," Andrea Hamm (Michigan Workers'

Comp Lawyers) on "Handling Michigan Workers' Compensation Cases," and Cathrine Wenger (La-Z-Boy, Inc.) on "An Overview of Employment Law." Robert D. Heitmeyer, Associate Area Counsel, United States Internal Revenue Service, presented a new topic "Tax Consequences of Routine Legal Transactions" to raise awareness on the topic and provide a basic primer on dealing with the IRS. Closing out the seminar were Leann Lizza, Shacara Mapp, and Sheri Ward, official court

reporters for the federal court, who discussed rules lawyers should follow to make a clean (i.e., accurate) record of transcribed proceedings. They demonstrated the creation of a transcript in Real Time and educated the participants on when transcripts are needed and how to request them.

As part of the New Lawyers' Seminar, attendees also had the opportunity to participate in a swearing-in ceremony to the United States District Court for the Eastern District of Michigan, which is held in the courthouse's beautiful

"Million Dollar" courtroom. Although originally scheduled as the concluding activity for the "federal day," the ceremony was moved to the second day so it could be conducted in person. Prior to the ceremony, Barbara Radke (Judicial Assistant to the Honorable George Steeh) provided registrants with an overview of the history and notable architectural details of this exquisite space. After the tour, Chief Judge Sean Cox greeted the participants individually and then admitted them to practice in the Eastern

District of Michigan upon motion for admission by Jeff May (Bodman) on behalf of the Chapter. Chief Judge Cox then spoke to the participants about the importance of the Chapter and the opportunities and resources it can provide to them in their careers, encouraging them to attend events and get involved. The ceremony concluded with a group photo with Chief Judge Cox framed around the storied bench and marbled backdrop of the Million Dollar courtroom.

The seminar's co-chairs, Christine Dowhan-Bailey, Grant Gilezan (Dykema), Lauren Mandel (Career Law Clerk to the Honorable Linda V. Parker), Jeff May (Bodman), and Cathrine Wenger (La-Z-Boy, Inc.), wish to thank the federal and state court judges who participated in the seminar, and who continuously give their time to this and other Chapter events throughout the year. We also thank all of the experienced and knowledgeable practitioners and court staff for their contribution, and Chapter Executive Director Mindy Herrmann for all the work she does to advertise the event and enable it to run smoothly.

# Law Clerk Committee Hosts Resume Workshop

On January 9, the Chapter's Law Clerk Committee hosted its annual panel discussion and resume workshop for current law clerks at the Theodore Levin Courthouse. The Law Clerk Committee, co-chaired by Sarah Resnick Cohen and Jeff Crapko, is comprised of former federal law clerks from both the district court and Sixth Circuit.

Committee members Judge Laurie Michelson, Jeff Crapko, Brittney Kohn, Lauren Mandel, Elyse Lisznyai, and Matt Allen participated in a panel moderated by committee member Jennifer Newby. The panel spoke to law clerks about the transition from clerking to practice. A robust group of law clerks from magistrate judge and district court chambers attended.

The workshop aims to help prepare law clerks for challenges they may face while clerking and as they transition

into practice, based on the personal experiences of the committee members. Because of the practice diversity of the panel, law clerks were able to hear perspectives from both private and government practice. The discussion also included tips on seeking post-clerkship employment. Those law clerks who submitted their resume to the committee received one-on-one feedback from a committee member during the workshop. The committee holds this event annually in January and all current law clerks are welcome to attend.

# 2024 Wade H. McCree, Jr. Luncheon Inspired Many By Melinda Herrmann

On February 7th, 2024, approximately 160 local practitioners gathered at the beautiful Detroit Athletic Club for the 2024 Wade H. McCree, Jr. Award Luncheon for Social Justice. This year's award recipient was Stephani LaBelle, Executive Director of Project Clean Slate (PCS), and the Keynote Speaker was professor Charles B. Dew, Ephraim Williams Professor of American History, Emeritus, at Williams College.

Project Clean Slate is a program created by Mayor Mike Duggan to assist Detroiters who want to work and be part of Detroit's comeback by providing free expungement services to residents. In 2019, Mayor Duggan worked with a bi-partisan group of state legislators to reform

the state's expungement legislation and in that process, Stephani LaBelle testified in support of the legislation in front of the Michigan House and Senate Judiciary Committees. The legislation was signed into law in 2020 more than doubling the number of Detroiters eligible for

expungement. Shortly after LaBelle's arrival, PCS adjusted its model and she transformed the expungement program. Stephani's criminal defense experience, effective case management style, and altruistic nature proved to be the key to PCS' success. One PCS expungement beneficiary, Mr. Richard Walker, also attended the luncheon and gave a very moving testimonial about the good work that that PCS organization, led by Ms. LaBelle, is doing.

While the luncheon always features amazing speakers, this was the first time in some time where the luncheon's Keynote Speaker was chosen specifically

to talk about the theme of the luncheon. Professor Charles Dew had been the Keynote Speaker for my daughter's graduation ceremony from Williams College and that connection spawned the chapter's invitation, which we were delighted to have had accepted. Professor Dew used his book, "The Making of a Racist - A Southerner Reflects on Family, History, and the Slave Trade" as the basis of his discussion, focusing on his upbringing in midcentury

American South, "in many respects a boy's paradise, but one stained by Lost Cause revisionism and, worse, by the full brunt of Jim Crow." (1) Through his book and his talk, Professor Dew aimed to inform our bar how the South of his childhood came into being, poisoning the minds even of honorable people, and he challenged

of honorable people, and he challenged the audience to be always cognizant and resistant to the hate that still permeates our society.

Attendees of the Wade H. McCree, Jr. Luncheon were inspired by the legacy of Wade H. McCree, Jr., and also by the works of Stephani LaBelle, the writings and discussion of Professor Dew, and the remarkable story of Richard Walker. To take advantage of that collective synergy, the chapter worked with its own Diversity Committee in orchestrating a follow-on event for the next day which included Professor Dew in a round-table luncheon program entitled, "Courageous

Conversations, Part II."

# Diversity Committee Spearheads "Courageous Conversations"

On February 8, 2024, the Chapter's Diversity Committee hosted a dynamic discussion tackling debates on racial inequality, privilege, and affirmative action. Titled

"Courageous Conversations, Part II: Building Bridges of Understanding," the event continued the Committee's 2021 dialogue about race and aimed to foster understanding among diverse groups, cultures, and races.

Moderated by Amir El-Aswad of Foley & Lardner, the engaging discourse featured United States Magistrate Judge Elizabeth Stafford, and United States District Judges Jonathan Grey and Susan DeClercq, as well as Charles B. Dew, Professor Emeritus of

American History at Williams College and keynote speaker for the 2024 Wade H. McCree, Jr. Luncheon.

Speaking to the packed room, the panelists candidly explored why conversations about race are considered "courageous" and how to encourage and navigate discussions touching upon uncomfortable topics. They

next addressed the effect of SFFA v. Harvard—the Supreme Court's landmark ruling that race-based affirmative action programs in college admissions are unconstitutional—and responded to different perspectives on affirmative action and the recent backlash to diversity, equity, and inclusion initiatives.

Sharing personal anecdotes and professional insights, the panelists answered questions from the audience and offered actionable takeaways. In

the professional sphere, they underscored the importance of having diverse perspectives in every room, creating environments where individuals can raise sensitive issues, and mentoring colleagues from different backgrounds. Firms can also promote access to justice and assist lawyers in meeting community needs by offering billable-hour credit for pro bono work.

For attendees striving to be better allies, the panelists encouraged them to keep open minds, educate themselves on issues like race, and reflect on and challenge their own implicit biases. The panelists also highlighted how humanizing, rather than otherizing, individuals who appear different from us can build bridges of empathy and understanding that transcend racial, cultural, and social divides. As Judge Grey insightfully remarked, "We are much more alike than we are different."

The Chapter's Bankruptcy Committee continues to be very active, holding two excellent and well-attended events in recent months.

First, on December 14, 2023, the Bankruptcy Committee partnered with the Chapter's Diversity Committee to host a Diversity, Equity, Inclusion, and Accessibility Allies Conference. The event brought top

professionals to discuss what allyship means to them, how it has impacted their careers, and how they have advocated for others and themselves. The 90-minute conference was moderated by Judge Mark A. Randon (U.S. Bankruptcy Court for the Eastern District of Michigan). McMillion (U.S. District Court for the Eastern District of Michigan), and Andy Vara (United States Trustee in Regions 3 and 9). The conference, which was conducted via Zoom, was well attended. Bankruptcy Committee leadership received a lot of very positive feedback about the stirring and inspirational personal stories shared by each of the panelists.

Second, the Bankruptcy Committee co-hosted the annual State of the Bankruptcy Court dinner on February 1,2024 at Zehnders in Frankenmuth. The evening featured a networking reception and a traditional Frankenmuth chicken dinner. Chief Bankruptcy Judge Daniel S. Opperman then gave a presentation on the state of the

Court, including a discussion of recent bankruptcy filing trends as well as some of the new initiatives that the Bankruptcy Court is working to implement in the coming months. A question and answer session followed. Approximately 80 people made the trip to Frankenmuth for this event.

The Bankruptcy Committee also has several great events planned in the coming months. On April 10, 2024, we are cohosting a webinar with the Wolverine Bar Association entitled, "A Bankruptcy Practice: Oh, the Places You Can Go." As the title suggests, the program will focus on how bankruptcy practitioners have used the skills learned in practice

to take on unique and interesting engagements outside of the traditional practice of law. Panelists for this program, which will be conducted via Zoom, include Hon. Mark A.
